3. Nominations are hereby invited for election as Directors, from the eligible Delegates, Kendriya Bhandar. Each nomination must be duly proposed and seconded and it must be countersigned by the candidate concerned, in token of willingness to contest as candidate. The nomination form in the prescribed format, as per Annexure, duly proposed, seconded and countersigned by the candidate, is required to be submitted to the officer designated by the Returning Officer to receive nominations on his behalf, within the time period allowed. It may be noted that any overwriting/correction in pen/usage of white fluid etc. shall render the nomination form liable for invalidation on this count alone.

4. Elections of Directors to the Board of Kendriya Bhandar would be conducted as per the provisions of the Bye-Laws of Kendriya Bhandar read with the MSCS Act, 2002 and Rules framed thereunder (as amended from time to time). Further, the declaration given by the contesting candidate in the nomination form and undertaking signed by the candidate would be scrutinised and matched with details of the candidate, his proposer and seconder, as available in the records with the Returning Officer, and in terms of instructions issued by the Department of Personnel and Training in respect of Government Servants holding elective office. Therefore, the candidates should carefully fill the nomination form and ensure that the entries match with the details in the available records, so as to avoid rejection of their nomination due to mismatch of data.

5. Elections of Directors to the Board shall be held between 10 a.m. to 5 p.m. on Saturday 31st December, 2022 at the designated place, under the supervision of Returning Officer or designated Polling Officer. The location of the polling station/place would be notified in due course. Counting of votes would be taken up on 2nd January, 2023 and results of the election shall be declared by 5 pm on 2nd January, 2023 by the Returning Officer.
